GTC intends to purchase a quantity of 1 each of the two pieces of equipment specified below.

Air Cycle (Heat Exchanger) Air Conditioning System Trainer Minimum requirements:

- Must be mobile, on wheels to easily move in and around lab environment
- Operate on 110 volts
- Fully functional air cycle system to include typical turbine aircraft air cycle technology.
- Must include Instructor operations training manuals with all wiring diagrams
- Must have ability to add system faults for student training
