Chair Lattimore called the meeting to order at 12:00 p.m. and welcomed board members, staff, and guests. Chair Lattimore announced that the press had been notified of the meeting in accordance with the Freedom of Information Act. Chair Lattimore acknowledged that the agenda was posted on the GTC website, and a quorum of board members was present.

Chair Lattimore presented President Miller with the Order of the Palmetto, the highest civilian honor awarded by the governor of South Carolina. Chair Lattimore recognized President Miller's extraordinary lifetime achievements, service, and contributions to higher education at the statewide and nationwide levels. As President Miller accepted the award, he received a standing ovation from those in attendance.

Approval of Minutes

President's Report

President Miller asked Dr. Knowles and Ms. Simer to provide a brief summary from the May 16, 2023, Marketing, Recruiting, and Enrollment Committee meeting. Summer enrollment is at 4,945 of the 5,500 goal. The report is available on BoardEffect.

President Miller provided the below updates:

- The Topping Out Ceremony for the new Prisma Health Center for Health & Life Sciences will take place on Thursday, May 25, at 11:00 a.m. on the grounds of the construction site.
- The ACCT Leadership Congress is October 9 12, 2023, in Las Vegas, Nevada.
- Renovations to the Administration Building are on schedule with completion expected in November 2023.
- The new parking lot is scheduled for completion in mid-August.
- Construction of the Prisma Health Center for Health & Life Sciences is on track.
- The Child Development Center in on target to move to its temporary location in June while the facility undergoes renovation. A big thank you to Dr. Royster and Greenville County Schools for making this temporary move possible.
- Legislative subcommittee for recommended changes to board appointments will be addressed in June.
- The college is very mindful of the national news about violence and looking at different types of notification systems and training. The most important thing is "if you see something, say something."
- A minor fire at CMI resulted in no significant damage or injuries, but classes were canceled due to smoke.

State Tech Board Update

Mr. Burns provided a brief update. State Board is keeping an eye on the state budget. Legislative Day was held in March at the State House. The State Tech Board is in the process of separating the State Foundation Board and the State Tech Board.

SCATCC Update

Mr. Shouse stated that the next SCATCC meeting is June 7, 2023, in preparation for end of year fiscal year. New officers will be confirmed and work will continue on the budgets for technical institutions.

CHE will convene the fourth week in June for a two-day meeting at Spartanburg Community College with a tour of USC Upstate and a full slate of work to be done, i.e. foundational changes, turnover, policies, and how to enforce properly. The governor is making changes to the CHE board. Mr. Batson has assumed the role of chair of the Committee on Finance and Facilities. There are 23 upcoming projects.
