



RESERVATION REQUEST FORM for SPEECH & ASSEMBLY by INDIVIDUALS & GROUPS

The freedom to engage in free speech is protected by federal law, state law and Greenville Technical College policy. Greenville Technical College enforces its right to place reasonable restrictions on the time, place and manner that free speech or expressive activities or events shall occur on its facilities, including but not limited to those set forth in Greenville Technical College’s Emergency and Safety Procedures Guide.

The purpose of this form is for individuals or groups to request and receive prior approval to engage in speech and assembly in designated areas as outlined in the Greenville Technical College Emergency and Safety Procedures Guide. The designated area for assembly is Parking Lot O on the Barton Campus. (Temporary Location is Parking Lot A due to construction). This form must be completed and returned to the Dean of Students Office in the Beattie Huff Student Center (Building 105, Room 218) at least three instructional days prior to the requested date(s) of use. The college reserves the right to give priority to college departments, recognized student organizations, students, faculty and staff. While on-site, a copy of the approved request form and/or confirmation email must be available for inspection upon request by college officials.

Frequency: To allow for access to these areas by others, individuals or groups will be permitted to request space for the purposes of speech, expression or assembly for up to five (5) days (consecutive or non-consecutive) per request.
